

Cincinnati Auto Expo 2024 Honda Motocompacto E-Scooter Sweepstakes Official Rules

No Purchase Necessary

Sweepstakes Begins Thursday, March 14th, 2024, and ends Sunday, March 17th, 2024

1. Eligibility:

All participants must be at least 18 years of age, have a valid driver's license, and be a legal resident of the United States or the District of Columbia. The Cincinnati Auto Expo 2024 Honda Motocompacto E-Scooter Sweepstakes ("Sweepstakes") is not open to residents of Arizona, Florida, New York, or Rhode Island. Each eligible person who submits a valid entry ("Entrant") unconditionally accepts and agrees to comply with, and abide by, these Official Rules, and the decisions of Sponsor (defined below), which shall be final and binding in all respects.

2. Sponsors:

Giveaway sponsored by the Cincinnati Northern Kentucky Honda Dealers and Greater Cincinnati Automobile Dealers Association (Collectively "Sponsor"). Employees of the Greater Cincinnati Automobile Dealers Association, its members, and their immediate families are not eligible to participate. Employees of the Cincinnati Northern Kentucky Honda Dealers, its members, and their immediate families are not eligible to participate, including employees of: Honda East, Jeff Wyler Honda of Colerain, Jeff Wyler Honda of Florence, Joe Morgan Honda, Performance Honda, Performance Kings Honda, and Jeff Wyler Superior Honda (Collectively "Participating Dealerships").

3. Entry Period:

The "Entry Period" begins March 14, 2024 and ends on March 17, 2024, during Official Show Hours of the 2024 Cincinnati Auto Expo. Entry forms must be received during the following show hours: between 5:00 PM and 9:00 PM Eastern Time, Thursday, March 14, 2024; between 11:00 AM and 9:00 PM Eastern Time, Friday, March 15, 2024; between 10:00AM and 5:00PM Eastern Time, Saturday, March 16, 2024; and between 10:00 AM and 5:00 PM Eastern Time on Sunday, March, 17, 2024. ("Official Sweepstakes Hours"). Greater Cincinnati Automobile Dealer Association's computer is the official time keeping device for the Giveaway.

3. How to Enter:

During the Entry Period, visit the 2024 Greater Cincinnati Auto Expo to scan a QR Code at the Cincinnati Northern Kentucky Honda Dealers Display area or at the Greater Cincinnati Auto Expo or at the Duke Energy Convention Center for access to a Giveaway Entry form. All entry forms must be received during the Official Sweepstakes Hours. NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT IMPROVE THE ODDS OF WINNING.

4. Entries:

All entries must be on official entry forms, no paper entries, photocopies, or hand-drawn entry forms will be accepted. Limit one (1) entry per person per day. Sponsor is not responsible for lost entries, technical failures, or unauthorized human intervention. All entries submitted become the property of the Cincinnati Automobile Dealers Association and cannot be returned.

Incomplete entries or entries which the judges determine, at their discretion, to be incorrect, illegible, or not in accordance with these rules will be disqualified without notice to the participant. Official rules available at the Cincinnati Auto Expo or by contacting the Greater Cincinnati Automobile Dealers Association at (513) 326-7100.

5. **Odds:**

Odds of winning depend upon the number of entries received.

6. **Winner Selection:**

From the entries received during the Entry Period one (1) winner will be randomly drawn from the entries received each day. Entries will not roll over or be included in the next day's drawing. A total of four (4) winners will be selected (one for each day of the Entry Period). A representative of the Greater Cincinnati Automobile Dealers Association will notify all winners using the entry information provided to Sponsor. Winners do not need to be present to win.

While reasonable attempts to notify winners will be made, it is the responsibility of the winner to be available for notification. In the case where a winner cannot be reached, no replacement winner will be chosen.

Except where prohibited, winners will be required to sign and return an Affidavit of Eligibility, Liability & Publicity Release ("Affidavit") as well as a W-9 form, which must be received by Greater Cincinnati Automobile Dealer's Association's representative within ten (10) days of the date notice or attempted notice is sent, in order to claim the prize. If a selected winner cannot be contacted, fails to execute and return the Affidavit and the W-9 form within the required time period, does not comply with these Official Rules, or does not take delivery of the prize in a reasonable time period, the selected winner forfeits the prize.

7. **Prize:**

Each of the four (4) winners will be awarded one (1) 2024 Honda Motocompacto E-Scooter with a Manufacturer Suggested Retail Price of nine hundred ninety-five dollars (\$995.00) from allocated or available stock at one of the Participating Dealerships to be determined by the Sponsor. **The total Approximate Retail Value ("ARV") of all prizes to be awarded is \$3,980.00.**

8. **Prize Conditions:**

Each winner must present a valid drivers' license with his/her photograph, name and address, proof of social security number, and sign an affidavit of eligibility and release to claim the 2024 Honda Motocompacto E-Scooter. Should a winner be deemed ineligible at the time of the drawing or subsequently at the time of delivery, according to the official rules, he/she will be automatically disqualified and will receive no compensation and/or prize. No cash substitution, transfer or assignment of prize allowed, except at the sole discretion of the Sponsor.

9. **Responsibility for Taxes and Fees:**

The winners of the 2024 Honda Motocompacto E-Scooter Sweepstakes are solely responsible for all applicable taxes, titling, license, registration fees, insurance, and any and all other

expenses not specifically listed herein that are incurred with winning and operating the vehicle.

10. Determinations are Final:

Sponsor's decisions are final and binding.

11. Authorization to use Image, Likeness, and Statements:

Unless prohibited by law, by submitting an entry form and accepting a prize, the winners agree that Sponsor shall have the right, in perpetuity and free of charge, to publish and/or broadcast by any means the name, city of residence, photographs, and statements of the winner without any further notification or permission.

12. Authorization to Contact Entrant:

By participating, entrant hereby expressly agrees that Sponsor may contact entrant by telephone, email, text message or U.S. mail using the information the entrant has provided for the limited purpose of notifying entrant that they have won a prize.

13. Release of Liability and Waiver:

By participating, Entrant agrees to release and hold harmless Sponsor and all respective parent companies, affiliates, subsidiaries, and their directors, officers, agents and employees, from all claims or damages, in equity or in law, arising out of participation in the Sweepstakes as well as any and all liability arising from the acceptance and/or use/misuse of the prize. PARTICIPATING ENTRANTS WAIVE ALL RIGHTS TO CLAIM PUNITIVE, INCIDENTAL AND CONSEQUENTIAL DAMAGES. WINNERS ASSUME ALL LIABILITY FOR ANY INJURY OR DAMAGE CAUSED OR CLAIMED TO BE CAUSED, BY PARTICIPATION IN THIS SWEEPSTAKES OR USE/MISUSE OR REDEMPTION OF THE PRIZE(S). SPONSOR IS NOT RESPONSIBLE FOR ANY TYPOGRAPHICAL OR OTHER ERROR IN THE PRINTING OF THE OFFER, ADMINISTRATION OF THE SWEEPSTAKES OR IN THE ANNOUNCEMENT OF THE PRIZE.

14. Exclusion of Warranties:

ALL WARRANTIES, IF ANY, BY THE MANUFACTURER ARE THEIRS, NOT THE SPONSOR'S, AND ONLY THE MANUFACTURER SHALL BE LIABLE FOR PERFORMANCE UNDER SUCH WARRANTIES. SPONSOR HEREBY DISCLAIMS ALL WARRANTIES, EXPRESS OR IMPLIED, INCLUDING IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.

15. Disputes:

Except where prohibited, Entrant agrees that any and all disputes, claims and causes of action arising out of, or connected with, the Sweepstakes or any prize awarded shall be resolved individually, without resort to any form of class action. All participating Entrants consent to the personal jurisdiction of federal and state courts located in Hamilton County, Ohio and agree that such courts have exclusive jurisdiction over all such disputes. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, Entrant's rights and obligations, or the rights and obligations of the Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of the state of Ohio without giving effect to any choice of law or conflict of law rules (whether of the State of Ohio or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Ohio.
